LJR Club

Overview

The Louis J. Robichaud (LJR) Club is a unique fundraising program that was founded in 2005 by the New Brunswick Liberal Association (NBLA). The LJR Club gives its members an opportunity to meet with business, community, and political leaders throughout the province. Money raised through the LJR Club helps ensure the future success of the Liberal Party at both the local and provincial levels. Your generous donation will help us continue to build the New Brunswick Liberal Party and help move our province forward.

When Does the LJR Club meet?

The LJR Club has exclusive receptions each year around the province either in conjunction with signature events or as stand alone, regional receptions. Details will be communicated to LJR members as to when and where events are happening as dates and times are confirmed.

How to Join the LJR Club?

It's easy to join the LJR Club and flexible payment options are available. The annual cost of the club is \$600 per year. This can be paid by cheque or credit card, and can be divided into automatic monthly payments. Joining the LJR Club costs \$50 per month and your membership is eligible for a generous tax credit. LJR contributions can will be split between the NBLA and the riding of your choice.

Legacy Donor

Overview

Become a Legacy donor! This is a new initiative launched in 2024 by the New Brunswick Liberal Association. Legacy donors will have the opportunity to simplify their annual contributions into the maximum allowable annual contribution of \$3,000 or to divide it over 12 automatic payments of \$250 per month, and you will receive the maximum allowable tax credit of \$500.

Legacy donors will have the opportunity to meet with business, community, and political leaders throughout the province. Legacy donor contributions help ensure the future success of the Liberal Party at both the local and provincial levels. Your generous donation will help us continue to build the NB Liberal Party and help move our province forward. Legacy donor contributions can either be directed to the NBLA or split 50/50 between the NBLA and the riding of your choice.
